We would like to welcome everyone to attend the Fulton County Historical Power Show the third full weekend in June every year – this year June 19-21, 2020. Our feature this year IH, J.I. Case and Farmall. Feature business Wilson Fertilizer & Grain and featured farm will be the Gohn Ag – check them out in big tent down in the exhibit field.

REGISTRATION: <u>ALL EXHIBITORS AND DEMONSTRATORS</u>: need to register at the admission gate area – which is located about half way back the field.
